Resource Council



### Income tax information

If you miss(ed) our income tax filing clinic on March 31 and April 1, please be aware that there are a number of tax credits for which you may be eligible. They include:

**Age amount credit:** Either you can claim this credit or you can transfer it to your spouse or common-law partner. Check eligibility requirements.

**Canada caregiver credit:** The family member must rely on you for necessities such as food, clothing and shelter.

**Disability tax credit:** The aim is to help offset some of the costs related to impairment.

**Medical expenses credit:** When your medical expenses exceed 3% of your net income.

Home accessibility expenses credit: For renovation expenses related to making your home more accessible.
